

GM's 2nd-Quarter Income Hits \$1.2 Billion

General Motors reported second-quarter net income of \$1.2 billion, or 75 cents a share, including a net loss from special items that reduced net income by \$2 million, or nine cents a share.

In the second quarter last year, GM's net income was \$1.5 billion, or 90 cents a share.

GM's financial report stated that net income for the second quarter of 2013 included an increase in tax expense of \$500 million, or 29 cents a share, compared with the second quarter of 2012.

Net revenue in the second quarter of 2013 was \$39.1 billion, compared with \$37.6 billion in the second quarter of 2012. Earnings before interest and tax (EBIT) adjusted was \$2.3 billion, compared with \$2.1 billion in the second quarter last year.

"We continue to perform well in the world's two most important markets, the U.S. and China," said Dan Akerson, GM chairman and CEO. "We also made further progress in our European business and saw the steady performance of our global brands, Chevrolet and Cadillac. For the

rest of the year, we'll focus on winning customers with high-quality vehicles at a compelling value."

GM North America reported EBIT-adjusted earnings of \$2 billion, compared with \$1.9 billion in the second quarter of 2012.

GM Europe reported an EBIT-adjusted of minus-\$100 million, compared with minus-\$400 million in the 2012 second quarter.

GM International Operations reported EBIT-adjusted earnings of \$200 million, compared with \$600 million in the second quarter of 2012.

At GM South America, EBIT-adjusted earnings were \$100 million, compared with basically zero in the second quarter of 2012.

GM Financial's earnings before tax was \$300 million for the quarter, compared with \$200 million

in the second quarter of 2012.

For the quarter, automotive cash flow from operating activities was \$4.5 billion and automotive free cash flow adjusted was \$2.6 billion.

GM officials said the automaker ended the quarter with very strong total automotive liquidity of \$34.8 billion. Automotive cash and marketable securities was \$24.2 billion compared with \$24.3 billion for the first quarter of 2013.

"Our results in this quarter were clearly pegged to winning vehicles like the Cadillac ATS, Chevrolet Impala and Opel Mokka," said Dan Ammann, GM executive vice president and CFO.

"We will continue to address our business challenges head-on, execute flawless launches of our future products and most importantly, satisfy our customers."

Woodward Dream Cruise to Begin Saturday, Aug. 17

The Woodward Dream Cruise is right around the corner – the corner of Woodward and 9 Mile.

The annual event started in 1995, when Nelson House and volunteers looked to raise money for a soccer field in Ferndale and recreate the heydays of the '50s and '60s, when youth, music and cars roamed Woodward Avenue. That year, 250,000 people participated, nearly ten times the number expected.
